

FY24 Extended Learning Mid-Year Report Instructions

Overview

The FY24 Extended Learning Mid-Year Report will open on **Dec. 15, 2023**, and is due **Jan. 31, 2024**. The report will be entered directly in ePlan. All 21st Century Learning Community Centers (CCLC) and Lottery for Education Afterschool Programs (LEAPs) grantees must submit a report for each active grant. For 21st CCLC, this includes cohorts 19, 22, and 23.


Survey Location and Completion

The Extended Learning Mid-Year Report is located in ePlan under *Data and Information*. The Extended Learning Mid-Year Report will automatically import grantees' active extended learning grants, and each active grant will have its own separate page that must be completed in full.

Report Completion Steps

1. Access the Report

The Extended Learning Mid-Year Report can be accessed under **Data and Information**. ePlan users with the role of *LEA 21st CCLC / LEAPs Director* will be able to access and complete the report. Once in the *Data and Information* section, select 2024 from the dropdown and click **Extended Learning Mid-Year Report** (Fig. 1), then change the status to **Draft Started**.



2. Complete the Report

For each active grant, complete the *Mid-Year Report* page as well as the *Program Income and Fees* page (as applicable). 21st CCLC cohort 23 and LEAPs grantees will also complete the Local Evaluation Plan page. Users only need to take action on pages for active grants; there is no need to visit pages if the organization does not have that grant. For example, if the organization has both a LEAPs and a 21st CCLC Cohort 22 grant, then the organization would only need to visit and complete those specific pages of the report. The box at the top of each page will be checked in the organization receives those funds. If the box is unchecked, no action is needed on that page. See the table below for a summary of the pages that must be completed by each grant.

21st CCLC cohort 2023 and LEAPs grantees must also complete the *Local Evaluation Plan* page. For <u>each</u> <u>site</u> operated, complete the tables to:

- 1. Identify a SMART Goal or Evaluation Question associated with <u>each</u> of the state's seven Performance Goals.
 - SMART Goals/Evaluation Questions listed should be tailored to what the site is focusing efforts on in 2023-24 and can be limited a specific sub-group (e.g., students who scored below proficient in previous end of year math state assessment, students who attend a specific program activity, students from a certain grade level, etc.) SMART Goals/Evaluation Questions should be meaningful to the site and align to activities offered.
- 2. Identify the data sources that will be used to demonstrate achievement of the goal or to answer the question.
 - Data can come from ELAP, another source available to the site, or gathered for the purpose of local evaluation to inform effectiveness of efforts. Data should be relevant to the goal or question.
- 3. Describe how you plan to analyze data from identified sources to assess results.

3. Submit the Report

Once all pages have been completed as applicable for all active grants, navigate back to the *Sections* page. Click **Draft Completed** at the top of the page to continue through ePlan approvals. The report must be in *LEA Authorized Representative Approved* status to be submitted to the department. Once the report is reviewed by the department, the status will be charged to *TDOE Extended Learning Mid-Year Report Director Approved*. If revisions are needed, the report will be returned to the organization with the status of *TDOE Extended Learning Mid-Year Report Director Returned with Feedback*. Requested revisions will be listed in the *History Log* and will also be emailed to the organization's extended learning contact.
